Dear Mr Christensen,

I can confirm that, based on the facts of your birth (in Australia on 30/6/1978 to a UK born mother), you do not have a claim to British citizenship. This is because, prior to 1 January 1983 when the British Nationality Act (BNA) 1981 came into force, British nationality could only be passed down through the male line to children born overseas.

A provision was introduced in 2003, by way of an amendment to the BNA 1981, which allowed for the Registration of persons born to British mothers before 1 January 1983 - however this required a positive action of application - followed by a ceremony at which citizenship is awarded to successful applicants.

If I can be of further assistance please let me know.

Subject: Citizenship check

Dear Mr Page and/or Ms Hughes,

I am writing to ascertain whether or not I am a citizen of the United Kingdom.

I am a Member of Parliament of the Commonwealth of Australia and, as such, holding UK citizenship could affect my eligibility to hold office in the Australian Parliament.

This morning I spoke to Ms Southworth in the British High Commission in Canberra, Australia who referred your names and email to me to seek clarification around this matter.

I was born in Australia on 30 June 1978 to a British mother.

My mother, Margaret Anne Christensen (nee O'Brien), was born in Glasgow on 31 July 1955 and came to Australia circa 1963. She was a UK citizen at the time of her arrival and remains a UK citizen until today. However, she no longer has a current UK passport but has an Australian passport and is on the Australian electoral roll. She is a permanent resident of Australia but not a citizen.

I have never applied or registered for citizenship, residency or the right of abode in either the UK or any of its colonies, protectorates, dominions or territories. In fact, I have never even been to the UK or any of its colonies, protectorates, dominions or territories in my life.

I have previously checked whether or not I am a British citizen via information on the UK government websites. I checked in 2009 and it was clear I was not a citizen. In recent weeks I have checked again and received the attached advice stating I am not a citizen of the UK.

Given this information, I wanted to see how I could get formal advice, not on the question of whether I may or am entitled to citizenship but on the specific question of whether I am a British citizen.

If my understanding is somehow wrong and I am a British citizen, could you elaborate on what basis? My understanding is that even if I was to consider registering as a citizen, I wouldn't be a citizen until that registration was complete and I had been sworn in via a citizenship ceremony.

I appreciate your assistance in this matter.

Thank you for your consideration and I look forward to hearing from you.
