United Kingdom

My paternal grandfather was a British citizen. However, under British law, the grandchildren of British citizens do not have an entitlement to British citizenship by descent.

Fiji

My mother's father was born in Fiji in 1898. Fiji was a British colony at the time. It is not clear whether my maternal grandfather was ever a Fijian citizen. He departed Fiji in 1912.

I was born in Australia in 1953.

Fiji became independent from Britain in 1970. Fijian citizenship was established under the *Fijian Constitution of 1970*. Under section 22 of the 1970 Constitution, only men could automatically transmit citizenship by descent – not women. Accordingly, even if my mother was a Fijian citizen, she could not have automatically transmitted Fijian citizenship to me.

Under section 11(1) of the Fiji Citizenship Act 1971 (1971 Act), an application could be made to register a child born to a Fijian citizen mother as a Fijian citizen, but that application had to be made while the child was a minor. No such application has ever been made in relation to me. Again, it is unclear whether my mother's father – let alone my mother – was ever a Fijian citizen.

The Fijian Constitution of 1990 introduced a prohibition on dual citizenship and stripped Fijian citizenship from those who acquired or retained foreign citizenship. Even if my maternal grandfather or mother had been a Fijian citizen, they would have been stripped of Fijian citizenship because of their Australian citizenship pursuant to section 28(3) of the 1990 Constitution.

The Fijian Constitution of 1997 (1997 Constitution) retained this prohibition on dual citizenship. Pursuant to Chapter III of the 1997 Constitution, Fijian citizenship ceased to be automatically transmitted by descent, and children of Fijian citizens could only acquire Fijian citizenship by registration. I can confirm that no such application to register to become a Fijian citizen was made on my mother's behalf while she was a minor, or at all. No such application has ever been made in relation to me.

The 1997 Constitution was suspended in 2009, following the 2006 military coup.

The military government issued the Citizenship of Fiji Decree of 2009 (2009 Decree), with effect from 10 April 2009. Pursuant to section 8(1) of the 2009 Decree, the child of a Fijian citizen could apply to register as a Fijian citizen. I reiterate that I have never applied to register to become a Fijian citizen, and no such application has ever been made on my behalf.

Accordingly, I have never acquired Fijian citizenship, I was not a Fijian citizen at the time of nomination for the 45th Parliament, and I am not a Fijian citizen now.
