In response to the above, under reference, document regarding the subject issue, we communicate the following:

According to article 27 of the Greek Nationality Code (L.3284/2004) combined with article 1 of the Provisions Code for Male Registries (L.2119/1993), the acquisition of greek nationality/citizenship is proven by the registration within the Municipal and Male Registries (cases of males) of the Greek State.

In the specific case, and after investigation conducted by our Offices in the Database of the National Registry, no such registration of McCORMACK Michael Francis (son) of Lance Trevalion (or Trevalism) Thomas and Eileen Margaret, born in 1964 in Australia, in either the Municipal or Male Registries appeared.

Furthermore, in regards to the grandfather of Mr. McCORMACK Michael Francis, namely George Peter MARGOSIS, allegedly born in 1896 in either Corinth or Akrata, following search conducted by our Offices, no registration of his in the Municipal and/or Male Registries of either the Municipality of Corinth or the Municipality of Aigialeia appeared.

Consequently, the acquisition of Greek citizenship by Messrs George Peter MARGOSIS and Michael Francis McCORMACK is not proven and, as per the provisions of the aforementioned legislation, they are not considered Greek citizens.

Απαντώντας στο ανωτέρω σχετικό έγγραφό σας αναφορικά με το αντικείμενο του θέματος, σας γνωρίζουμε τα ακόλουθα:

Σύμφωνα με το άρθρο 27 του Κώδικα Ελληνικής ιθαγένειας (Ν.3284/2004) σε συνδυασμό με το άρθρο 1 του Κώδικα Διατάξεων περί Μητρώων Αρρένων (Ν.2119/1993) η κατοχή ελληνικής ιθαγένειας αποδεικνύεται με την εγγραφή σε Δημοτολόγιο και σε Μητρώα Αρρένων (σε περίπτωση άρρενος) ελληνικού Δήμου.

Στην προκειμένη περίπτωση από την διενεργούμενη από την υπηρεσία μας έρευνα στη Βάση Δεδομένων του Εθνικού Δημοτολογίου προέκυψε ότι ο McCormack Michael Francis του Lance Trevalion (or Trevalism) Thomas και της Eileen Margaret, γεν. το έτος 1964 στην Αυστραλία δεν είναι εγγεγραμμένος σε Δημοτολόγιο ελληνικού Δήμου.

Επιπλέον, αναφορικά και με τον φερόμενο ως παππού του εν θέματι, υπό στοιχεία George Peter Margosis γεν. το 1896 στην Κόρινθο ή την Ακράτα, κατόπιν σχετικής έρευνας της υπηρεσία μας, δεν προέκυψε εγγραφή του στα Δημοτολόγια ή/και τα Μητρώα Αρρένων του Δήμου Κορινθίας ή του Δ.Αιγιαλείας.

Κατά συνέπεια, για ουδένα εκ των ανωτέρω δεν προκύπτει η κατοχή ελληνικής ιθαγένειας και δεν θεωρούνται Έλληνες πολίτες κατά τα διαλαμβανόμενα στις προαναφερθείσες διατάξεις.
