I have checked my ancestry and am satisfied it consists entirely of English, Welsh and Irish ancestry to my grandparents' time, and before that there is some Scottish connection. The only citizenships I can be eligible for as a birthright are therefore from the United Kingdom (given England and Wales do not offer their own citizenship rights) and from Ireland. I have formally renounced my citizenship of the United Kingdom and the possibility of citizenship of Ireland.

My spouse is Australian-born, as is both her birth mother and her adoptive mother. My spouse's grandparents by birth were Australian-born, with some English and Irish connections in their ancestry. My spouse's adoptive grandparents were Australian-born and also hail from English ancestry. I do not believe I am entitled to any citizenship rights via my marriage in 1995, and certainly not to any nation other than those whose citizenships I renounced in 2012 and 2016.

I have never sought nor accepted citizenship of any other nation other than that of Australia, which was acquired in 1981.

Given all the above I am satisfied I hold no citizenship other than that of Australia, and have no rights to citizenship other than that of Australia.
