I was born in Gosford NSW and I have never held any other citizenship than Australian. I have never taken any action to become a citizen of another country.

I had conducted my own extensive investigations about my qualifications prior to nominating for election.

Once Mr Joyce made his discovery of his citizenship I contacted the British High Commission and the Home Office to seek written confirmation of what I already knew as fact. This was done on the basis that it may be eventually needed to satisfy media speculation.

I made application for confirmation to the British Home Office and paid 234 pounds!

I have received written confirmation that I have not acquired British citizenship and confirmation that I have no automatic claim to British citizenship as a consequence of my mother's birth in the UK.

Confirmation from the British Home office is attached.

It is a great honour to serve in the House of Representatives representing the great people of Tangney after having sworn an oath to Her Majesty Queen Elizabeth II, Queen of Australia!
