| Prior to 1 January 1985, if a person was born from a Dutch mother and a foreign father they did not become a Dutch citizen by law; therefore, my Father, born in 1921, did not acquire citizenship from his Mother when he was born in Australia. Even if this was the case I would not hold Dutch citizenship as under article 15c of the new Dutch Nationality Act (unofficially translated) "a person who is of full age shall lose his or her Netherlands nationality if he or she also has a foreign nationality and, after coming of age and while possessing both nationalities, has his or her principle place of residence for a continuous period of ten years outside the Netherlands, the Netherlands Antilles and Aruba, in the country of that other nationality and in which he or she has been born, other than in the service of the Netherlands, the Netherlands Antilles or Aruba and/or of an international body". |

| As I obtained Australian citizenship at birth, and have lived outside of the Netherlands (in Australia) for a continuous period of over ten years after my 18 <sup>th</sup> birthday, I would have lost any Dutch dual citizenship even if I had obtained it by descent (which I did not).   |
